

Cookie policy



NT K+D AG Cookie Policy

The aim of this Cookie Policy ("Policy") is to provide you, as a user of NT K+D AG's services, with clear and accessible information about the cookies used by NT K+D AG, and to inform you to what extent cookies help us to offer you the best possible experience.

1. What are cookies and other similar technologies?

Cookies are text files that are downloaded to your device when you visit a website. They are useful because they allow a website to recognise a user's device.

The term "cookie" actually encompasses a variety of technologies, including:

- Pixel tags (transparent graphic images that are placed on a website or in an email and indicate that a page or email has been viewed),
 - Mobile device identifiers, and
 - Web storage technology used in desktop software or on mobile devices.
- We use the term "cookie" in this policy to refer to all of these technologies. We aim to give you clear information about all the technologies to help you make informed decisions about your cookie settings. Cookies do many different jobs. For example, they enable you to navigate efficiently between different pages, remember your settings, and generally ensure a better user experience. They can also help in making the ads you see online more relevant to you and your interests.

There are different categories of cookies, including:

• **Session cookies and persistent cookies**

Session cookies – these cookies expire as soon as you close the web browser.

Persistent cookies – these cookies remain on your device for a specified period of time or until you delete them.

• **First-party and third-party cookies**

First-party cookies – these cookies come from the website you are currently visiting, either from us or from a third party at our request;

Third-party cookies – these cookies come from a third party that is independent of the website you are visiting. If you visit the NT K+D AG website or use NT K+D AG services and a third party places a cookie via this website, it is a third-party cookie.

Cookies also differ depending on the purpose for which they are used

• **Strictly Necessary Cookies**

These cookies are required to enable you to use the features of our services. Without these cookies, services you have requested cannot be provided. In summary, these cookies make possible the services that you have specifically requested, and enable the use of our services.

• Performance-Cookies

These cookies collect information about how visitors use our services, e.g. which pages are visited most often or whether visitors are shown error messages on web pages. These cookies collect anonymous information on the pages visited. All information collected by these cookies is aggregated and is therefore anonymous. They are only used to improve the performance of our services. This category includes web analytics that use cookies to collect data to improve the performance of a website. They can be used, for example, to test designs or to ensure that the user is presented with a uniform appearance. This category does not include cookies that are used for behavioural/targeted advertising networks.

• Functionality Cookies

These cookies enable the website to remember the settings you have selected (e.g. your user name, your language and your region) and to provide better, more personal functions. These cookies can also be used to remember changes you have made to text size, fonts and other customisable parts of web pages. The information these cookies collect can be anonymised and cannot be used to track your browsing activity on other websites. These cookies remember settings that you select to improve your user experience. If the same cookie is used for retargeting purposes, it also belongs to the category "Targeting or Advertising Cookies". This can include cookies that are used to fulfil a specific function, but if that function includes cookies that are used for behavioural/targeted advertising networks, these belong to both the "Targeting or Advertising Cookies" category and this category.

• Targeting or Advertising Cookies

These cookies are used to deliver advertisements that are more relevant to you and your interests. They are also used to limit the number of times you see an ad, and help evaluate the effectiveness of advertising campaigns. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website. This information is shared with other companies such as advertisers. Targeting or advertising cookies are often linked to the website functionality provided by the other companies. These cookies collect information about your browsing habits in order to help make the advertising relevant to you and your interests.

2. How does NT K+D AG use cookies?

NT K+D AG, or the service providers acting on our behalf, use the cookies mentioned in Section 1 in the following ways:

• Absolutely Necessary

These cookies are necessary so that we can operate the NT K+D AG services you have requested.

• Performance/Analysis

We use cookies and other similar technologies to analyse access to NT K+D AG services and to assess their use and performance. We use this information to maintain, operate and continually improve NT K+D AG's services.

We may also receive information via our e-mail newsletters or other communications that we send you, including information about whether you opened or forwarded a newsletter or clicked on its contents. With the help of this information, we can evaluate the effectiveness of our newsletters and ensure that we provide information that you find interesting.

• Functional

These cookies enable us to operate the NT K+D AG services according to your settings. For example, if you continue to use the NT K+D AG services or return to them, we can provide our services to you on the basis of the information you have already provided – e.g. by remembering your username and how you have customised our services, and by reminding you of the content that you have previously accessed.

• Targeted Advertising

We use these cookies and other similar technologies to make available to you advertising that may be relevant to you and your interests, including interest-based advertising. This information may also be used to track the number of times you have been shown a particular ad, to help avoid repeated showing of the same ad, and otherwise to help measure its effectiveness.

• Third Party

We may allow our business partners to use cookies or other similar technologies for the above purposes, in the context of or outside of the NT K+D AG services, including to collect information about your online activities over time and on/in different websites, applications and/or devices.

• NT K+D AG advertisements

We work with website operators, application developers, advertising networks and service providers to provide advertisements and other content that advertises NT K+D AG on other websites and with other services. Cookies and other similar technologies may be used to provide you with advertisements on/in other websites, applications and devices that may be relevant to you and your interests, and to regulate the advertisements provided to you and to measure their effectiveness.

3. How can you manage your cookie settings?

• Browser cookies

You can revoke or change your consent to our use of cookies at any time. If you no longer wish to receive cookies, you can use your browser settings to accept, reject or delete cookies. To do this, follow your browser's instructions (usually in the settings under "Help", "Tools" or "Edit"). Please note that if your browser rejects cookies, you may not be able to use all functions on the NT K+D AG website.

• Mobile device identifiers

On your mobile device, the operating system can provide you with further options to deactivate interest-based advertising or to reset mobile device identifiers in other ways. For example, you can use a "No ad tracking" setting (on iOS devices) or a setting to deactivate interest-based advertising (on Android devices) to restrict the use of information relating to your app usage for the purpose of providing advertisements that are targeted to your interests.

• Cookies in desktop applications

You can revoke your consent to our use of cookies in any desktop application that NT K+D AG may make available for use at any time. In such cases: If you no longer wish to receive cookies, go to the account settings page and activate the function to disable desktop cookies. If this function is activated, cookies will be blocked in the particular installation of the NT K+D AG desktop application on the particular computer; if the application is installed on several devices or you install the application again, the function must be activated for each installation. The application must be restarted for this function to take effect.

Note: If you have set a desktop application to block cookies, your app experience may be impaired.

• Interest-based advertising

Certain targeted advertisements that we (or a service provider acting on our behalf) show you, based on information about your online activities on websites and other interactive properties operated by third parties, may contain the "AdChoices" symbol or some other mechanism with which you can deactivate the receipt of interest-based ads. Click on the AdChoices symbol or visit www.aboutads.info for further information about the collection and use of information about your online activities for interest-based advertising, or to learn how you can deactivate the use of your data for interest-based advertising by participating companies of the Digital Advertising Alliance (DAA).
